



Safeguarding the Health and Wellbeing of East Palestine



We're making it right in East Palestine and fulfilling our long-term commitments to address drinking water, home values, and healthcare. To date, we have contributed more than **\$108 million** to East Palestine and the surrounding areas and conducted thousands of tests that show the air and water are safe.



Physical and Mental Health

We are dedicated to the long-term wellbeing of East Palestine citizens. Our commitments include:

- ✓ **\$25M** Community Health Program providing medical exams and mental health services for the community and first responders for up to 20 years (subject to court approval).
- ✓ **\$21.5M** in direct financial assistance to local families.
- ✓ **\$2M+** to establish the State of Ohio medical facility in East Palestine and reimburse the State of Ohio for care patients received at the East Palestine Clinic.
- ✓ **\$1.8M** in funding to a local East Palestine clinical counseling and wellness practice supporting the mental well-being of local residents.
- ✓ **\$623,000** to fund a state-run Community Resiliency Center to address mental health issues.
- ✓ Through the **Family Assistance Center (FAC)**, residents have been reimbursed for out-of-pocket medical bills.
- ✓ **\$600M** comprehensive settlement agreement for individuals who can use the compensation in any manner they see fit to address potential adverse impacts from the derailment.



Environmental Testing and Monitoring

We have completed the majority of site remediation and have taken steps with local, state, and federal authorities to help ensure the community is safe moving forward, including:

- ✓ **\$5M** state-of-the-art carbon filtration system for the municipal water supply
- ✓ **600+** in-home air tests
- ✓ **68M+** gallons of impacted water recovered and transported offsite
- ✓ **177,000+** tons of waste soil shipped off site
- ✓ Subject to court approval, we have also committed to the following:
 - **\$15M** to establish a drinking water monitoring program
 - **\$10M-\$15M** to continue monitoring of groundwater and surface water
 - **\$7M** to address pre-existing pollution and improve water quality
 - **\$57M** to reimburse the EPA for its full response expenses



Safety Improvements

We committed to improving safety across the industry and to ensure East Palestine's first responders have what they need in the future. We have committed:

- ✓ **\$244M** for safety initiatives and investments in safety infrastructure, technology, and training, as part of the company's Six Point Safety Plan. This includes deploying additional hot bearing detector systems and new Digital Train Inspection portals.
- ✓ **\$25M** for a new regional safety training center to provide ongoing, free training for first responders in the area.
- ✓ **\$9M** to reimburse first responders for all charges related to the derailment, including replacing their Self-Contained Breathing Apparatus air packs and a new ladder truck for the East Palestine Fire Department.
